4. First-aid Measures

Description of first-aid measures.**General advice.**

5. Fire-fighting Measures

Extinguishing media.

Suitable extinguishing media.

Use.: Dry powder. Alcohol-resistant foam. Carbon dioxide (CO₂). Water may be used to cool and prevent the rupture of containers that are exposed to the heat from a fire.

Extinguishing media which shall not be used for safety reasons.

6. Accidental Release Measures

Personal precautions.
