4. First-aid Measures

Description of first-aid measures.

General advice.

Move victim to a safe isolated area. When symptoms persist or in all cases of doubt seek medical advice. Call a poison control center or doctor for treatment advice.

5. Fire-fighting Measures

Extinguishing media.

Suitable extinguishing media.

Use:. Dry powder. Alcohol-resistant foam. Carbon dioxide (CO₂). Water may be used to cool and prevent the rupture of containers that are exposed to the heat from a fire.

Special hazards arising from the substance or mixture.

Vapors may travel to areas away from work site before igniting/flashing back to vapor source. Thermal decomposition can lead to release of irritating and toxic gases and vapors. Most vapors are heavier than air. Vapors may spread along ground and collect in low or confined areas (sewers, basements, tanks). Vapors may travel to source of ignition and flash back.
